## 1. STRATEGIC FOCUS & CHALLENGES

EIT Urban Mobility (EITUM) is an initiative supported by the European Institute of Innovation and Technology (EIT) acting to accelerate positive change on mobility to make urban spaces more liveable since January 2019. EITUM aims to become the largest European initiative transforming urban mobility and the reference in the market for supporting and funding gender-balanced start-ups within urban mobility.

### Description of the programme and offering

**SCALE-UP PROGRAMME** is one of the programmes funded by EITUM intended to support start-ups. The **SCALE-UP PROGRAMME** is therefore an EU-funded project: a consortium of partners is implementing the project with the financial support of EITUM. The aim of the programme is to support mature start-ups (from EU and Horizon Europe associated countries) in their international growth phase. In particular, the programme is designed to offer to selected mature-stage start-ups:

#### EVENTS, NETWORKING and PROMOTION

- Increased visibility via pitching events and programme partner's networks
- Participation at internal and high-level international events such as [IAA MOBILITY](#) (Munich, Germany), [URBIS Smart City & Future Mobility](#) (Brno, Czech Republic); The participation may consist, depending on each event on: live pitching, booth options, networking opportunities with city and industry reps, matchmaking with VCs, expert workshops...<sup>1</sup>
- Tickets to Tomorrow.Mobility 2023, organised by Fira de Barcelona and co-organised by EIT Urban Mobility. One of the most influential start-up events in Europe with a specific focus on the future of mobility within cities;
- 2,500€ lump-sum contribution (eligible cost categories is "travel, accommodation, and subsistence costs") for attending the programme's activities;
- Access to city and industry network for exploring potential pilots;
- Promotion of your start-up at the [Impact Ventures portfolio webpage](#), and through EIT Urban Mobility communication channels;

#### FUNDING OPPORTUNITIES

- Access to investors and potential clients
- Access to EIT Urban Mobility investment initiatives and funding instruments;

- Expert webinars and workshops by industry experts and experienced executives such as Pilot Preparation, Advanced Sales & Negotiations Coaching, Stop Guessing & Start Failing (PowerHUB Buildinn Academy).

The **SCALE-UP PROGRAMME** will be a precursor and will **support 12 start-ups** during 2023 with a cross-thematic focus on so that they develop and implement innovative solutions in the field of urban mobility.

The program will focus on mature start-ups from the urban mobility landscape. It will provide personalised business coaching, mentorship, access to a network of leading cities and industries. This will help bring the start-ups solutions across Europe and achieve their business goals and conquer new milestones.

Through tailored mentorship designed to cover your needs, you will be able to scale-up your company and get the exposure you need. Start-ups are key to drive innovation across our cities and solve the current challenges we face, and we want to help you bring your solution to life and spread it across new territories, thanks to the pitching opportunities included in the offering.

The overall goal of the programme is to support start-ups in their international growth phase, new sales, and investment opportunities.

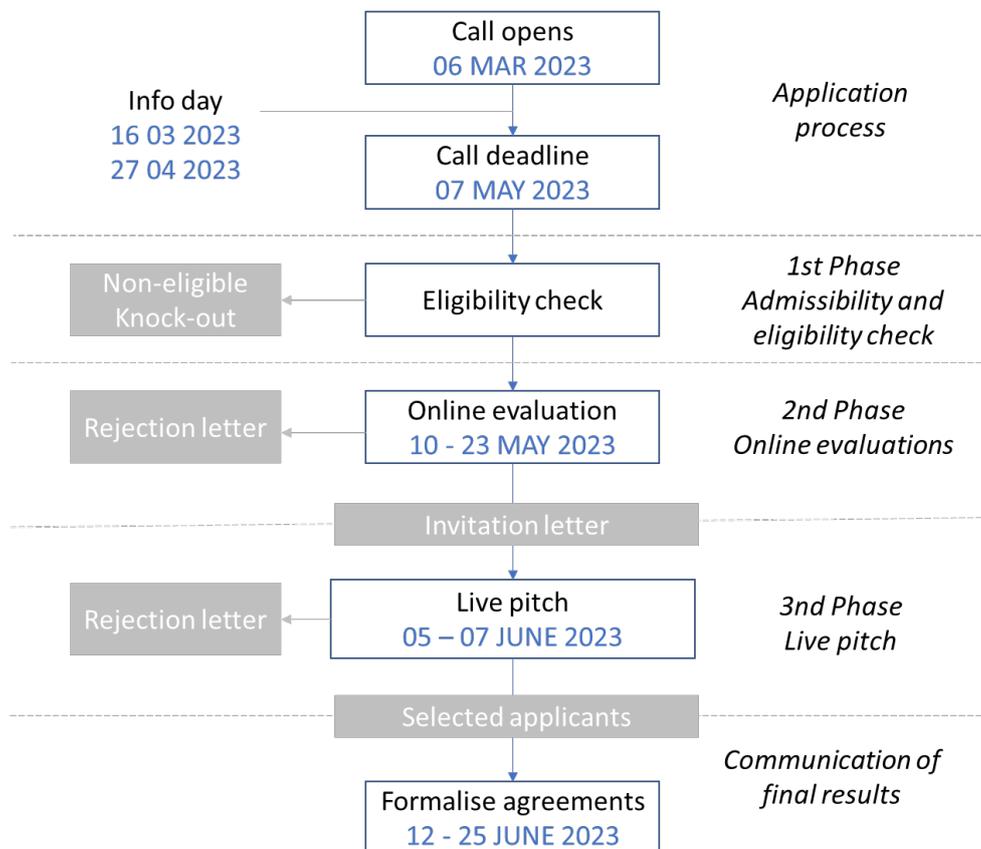

### 3. ADMISSIBILITY AND ELIGIBILITY CRITERIA

Applicants will have to comply with the following **eligibility criteria (yes/no)**:

- The submitted application is in English language;
- A team with at least **3 FTE**. NOT a single founder. Not necessarily connected to monetary compensation;
- **START-UP incorporated in EU or EU associated countries** according to the official list of countries by the European Union and [third countries associated to Horizon Europe](#). The registration certificate will be required to participate in the program<sup>2</sup>;
- **Not having been selected** and benefited from previous editions of the programme, which are **Scale-up Hub (2020), ScaleTHENGlobal (2021), Scale-up programme (2022)**;

### 4. AWARD CRITERIA

Applications should comply with the following **award criteria (scoring)**:

- A **clear, scalable business idea**;
- **Founders and employees** (e.g. Employee Stock Ownership Plan, ESOP) should still own more than **50% of shares**;
- **No more than 10% of your shares are held outside of the eligible countries** (no detailed cap table needed);
- Duly justified, preferred **TRL 7 – 9**, according to TRL definition in [Horizon Europe Work Programme 2023 – 2024](#);
- **FIT with EIT Urban Mobility Scale-up Programme**: Teams will be asked to elaborate how they will engage and contribute to the Scale-up programme:
  - o Due to its cross-thematic focus, applicants are suggested, but not limited to contribute to at least one of the following fields or areas:

## 5. HOW TO APPLY

Go to <https://eiturbanmobility.awardsplatform.com/> (PLATFORM)



START-UP representatives must **register and validate the account** if this is the first time accessing the platform. If START-UP representative has already created an account, proceed to **log in**.

Once logged in:

1. Start a new application;
2. Select Chapter EIT UM – Impact Ventures;
3. Select Category – **Scale-up Programme 2023**;
4. Follow the application form.

During the application all compulsory fields must be filled. Details about the application form, sections and required information are included in [ANNEX 1 - Application form, sections and required information](#).

## 6. EVALUATION PHASES AND CRITERIA

The evaluation of proposals and fit with the defined challenges will be conducted in **three phases**:

### 1<sup>st</sup> phase – Admissibility and eligibility check

START-UP applications will be first checked following a yes/no criteria (knock-out criteria). Applications meeting all the **formal eligibility requirements** will be selected for phase 2 - online evaluation.

### 2<sup>nd</sup> phase – Online evaluation

START-UP applications will be reviewed by a **panel composed by at least 4 evaluators** with same weighting of scores:

- 1 member from EIT Urban Mobility – Impact Ventures area (1/4);
- 3 external experts nominated by **SCALE-UP PROGRAMME** consortium (3/4).

Each evaluator will have to score each STARTUP application based on **four standardised criteria** for a maximum of 20 points: **Excellence / Innovation** (5 points), **Team / structure** (5 points) **Impact** (5 points), **Implementation and overall merit** (5 points). The average of all evaluators scores will give the online evaluation score for a given applicant.

Top 24 ranked START-UP applications will qualify to phase 3 – the live pitch. Once the four evaluators have concluded their assessment, a Consensus Meeting is organised: for each application a final score will be decided, and a brief evaluation report will be produced. Applicants will be notified via e-mail about the outcome of the evaluation.

### Scoring criteria – 2<sup>nd</sup> Phase

Each criteria will be assessed according to the following scoring system:

### 3<sup>rd</sup> phase – Live pitch

START-UPS will pitch their candidacy to join the **SCALE-UP PROGRAMME** to a **panel composed by at least 4 jury members**:

- 2 members from EIT Urban Mobility – Impact Ventures area (2/4);
- 2 external experts nominated by **SCALE-UP PROGRAMME** consortium (2/4).

Each evaluator will have to score each STARTUP application based on **two standardised criteria** for a maximum of 20 points: **Pitch** (10 points), **Overall fit to programme** (10 points). The average of all evaluators scores will give the total score for a given applicant.

The format of the live pitch will be 3 minutes presentation by the START-UP and up to 7 minutes questions from the jury panel. Once the four evaluators have concluded their assessment, a Consensus Meeting is organised: for each application a final score will be decided, and a final evaluation report will be produced.

The total score of phase 2 will be added to the total score of phase 3. Top 12 ranked START-UP applications will be conditionally accepted<sup>3</sup> to join the **SCALE-UP PROGRAMME**. If conditions are met, the START-UP will be granted the support service package. Applicants will be notified via e-mail about the outcome of the evaluation.

### Scoring criteria – 3<sup>rd</sup> phase

Each criteria will be assessed according to the following scoring system:

## 7. COMMUNICATION OF RESULTS

Results will be communicated to the email of the startups representative registered at the AwardForce platform. *Note: Please, check your junk folder too!*

- Phase 1 results will be communicated with a rejection letter to non-qualified applicants;
- Phase 2 results will be communicated with a rejection letter and a brief evaluation report to non-qualified applicants; and an invitation to the live pitch for the qualified applicants;
- Phase 3 results will be communicated with a rejection letter and a final evaluation report to non-qualified applicants; and an announcement letter and a final evaluation report to selected start-ups.

The start-up point of contact of any application deemed inadmissible/ineligible who disputes the ineligibility decision, may appeal. This appeal must be sent to [impact.ventures@eiturbanmobility.eu](mailto:impact.ventures@eiturbanmobility.eu) within 5 calendar days from the official notification of ineligibility, by identifying and describing the factual errors that according to the applicant invalidate the decision. A final decision on the appeal is taken by the Programme consortium.

## 8. ACTIVITIES IMPLEMENTATION AND FINANCIAL ASPECTS

Selected start-ups will have to diligently collaborate to:

- Provide the registration certificate (mandatory to provide at the latest 5 calendar days after the selected start-up receives notification of conditional acceptance);
- Sign the legal agreement with the SCALE-UP PROGRAMME (mandatory to provide when an applicant has been conditionally accepted and before the SCALE-UP PROGRAMME starting date);
- Include on the webpage of their organisation a clear reference to EIT UM and to the SCALE-UP PROGRAMME (mandatory to provide when an applicant has been conditionally accepted and before the SCALE-UP PROGRAMME starting date);
- Drawing-up SCALE-UP PROGRAMME documentation for reporting purposes towards EIT;
- Complete and submit in due time the monitoring survey/s which will be provided by the Scale-up Programme;
- Actively promote the participation at SCALE-UP PROGRAMME to reach public audience.

After the evaluation and selection process, SCALE-UP PROGRAMME will grant each selected start-up with a fixed lump sum of 2,500 €. This amount is meant to cover the travel, accommodation, and subsistence costs<sup>4</sup> of the representatives of the start-ups when attending SCALE-UP PROGRAMME and EIT UM events during 2023 (see [Annex 2](#)).

## ANNEX 2 – Lump sum contribution of 2,500€

### Impact Ventures: Scale-up Programme support to selected start-ups

#### Type of Activity

Scale-Up Programme provides support for innovative mobility solutions by nurturing start-ups. This includes, among other support services, business coaching, mentoring by industry experts as well as urban mobility specific expertise such as technology or market validation, product-market fit or market entry. Scale-up Programme will nurture start-ups from the EU and Third countries associated to Horizon Europe.

The Scale-up Programme performs a scouting service for EIT Urban Mobility in identifying, evaluating, and selecting the most promising start-ups to be involved in the Scale-up Programme' activities.

For start-ups, the benefits of being selected in the Scale-up Programme comprise:

- Mentoring and coaching, technology development, product-market fit, business model fine-tuning and other valuable acceleration/scale-up services;
- Financial support for attending the Scale-up Programme' and EIT UM events (including bilateral meetings).

#### Grant amount and types of expenses

After the evaluation and selection process, Scale-up Programme will grant each selected start-up a fixed lump sum of 2,500 €. This amount is meant to cover the cost of the human resources (daily rate), travel, accommodation, and subsistence costs of the representatives of the start-ups when attending a minimum of two Scale-up Programme and/or EIT UM onsite events (including bilateral meetings) during the period 01.06.2023-31.12.2023.

#### Requirements for awarding the grant

- The start-up should be successfully selected by the Scale-up Programme in an open call;
- The start-up must commit to take part in the Scale-up Programme activities to justify the lump sum.
- The start-up must display prominently the EIT UM logo on its website

#### Payment process

Once the start-up is successfully selected by the Scale-up Programme open call, an agreement will be signed between the Scale-up Programme consortium partner managing the financial contribution and the start-up. The Lump Sum will be transferred to the start-up by the Scale-up Programme consortium partner managing the financial contribution after the signature of the agreement.

#### Supporting documentation

As there is no financial reporting, there are no financial checks, reviews or audits related to actual costs and the resources used. We do not impose any obligation to keep financial records in lump sum grants. Please note that participating start-ups will have to comply with record-keeping obligations outside the agreement signed with the Scale-up Programme, e.g. under national law or internal procedures.

Controls will focus on the proper attendance of the start-up at the events/meetings organised by the Scale-up Programme and EIT UM during the duration of the Scale-up Programme activities. To prove the attendance at the event/meeting, the following evidence will need to be provided:

- copy of the list of attendance provided by the Scale-up Programme, in case of online meetings;
- signed participants list provided by the Scale-up Programme, in case of physical meetings.

In case of non-attendance to at least two onsite Scale-up Programme or EIT UM events, the Scale-up Programme reserves the right to reclaim the grant from the start-up.
