PRIVACY POLICY

The purpose of this Privacy Policy is to inform participants of the raffle about the collection and processing of their personal data (hereinafter, "Personal Data" or "Data").

1. WHO IS THE CONTROLLER OF THE PROCESSING OF YOUR DATA?

2. WHAT DATA DOES EIT KIC URBAN MOBILITY S.L.U PROCESS?

The Personal Data that EIT KIC Urban Mobility S.L.U process are obtained from information that you provide EIT KIC Urban Mobility S.L.U. as user by participating on the raffle and when you browse the Website.

Remember that it is your responsibility to provide accurate Data and keep them updated, EIT KIC Urban Mobility S.L.U reserves the right to exclude from the raffle users who provide false, incorrect or without proper authorization of the Data subject, without prejudice to the right of EIT KIC Urban Mobility S.L.U. to exercise all appropriate legal actions.

3. FOR WHAT PURPOSE DOES EIT KIC URBAN MOBILITY S.L.U. PROCESS YOUR PERSONAL DATA?

Your Personal Data are processed to:

- a) Participate in raffles or promotions. To participate in raffles in social media, promotions, through any of channels provided by EIT KIC Urban Mobility S.L.U., that EIT KIC Urban Mobility S.L.U might carry out, you must provide all the information required in each form. We may also use your information to contact you in connection with such raffle (notify the prize) or promotion and to provide you with additional offers and information about EIT KIC Urban Mobility S.L.U and/or new raffles.
- b) Browse the Website. When you visit the Website EIT KIC Urban Mobility S.L.U. could analyze and measure information about your navigation, improve usability and User experience on the Website statistically. EIT KIC Urban Mobility S.L.U. installation and use of cookies depends on the settings you make both in the cookie banner and through your browser.

4. WHAT IS THE LEGAL BASIS FOR PROCESSING YOUR DATA?

The legal basis for the participation in the raffle and receive commercial communications is the consent given through your participation on the raffle.

The legal basis for the analyse of the information taken from your interaction with the Website is the consent you give EIT KIC Urban Mobility S.L.U with the acceptance of the cookies installation, consent that can be withdrawn or modified at any moment, and EIT KIC Urban Mobility S.L.U. legitimate interest to grant the operability of the Website.

Remember that you can revoke your consent at any time. You may also object to continue receiving commercial communications in the manner indicated in the footer of each communication.

5. HOW LONG WILL EIT KIC URBAN MOBILITY S.L.U KEEP YOUR DATA?

Your Personal Data are conserved for the period necessary for the purpose for which they were collected, and specifically:

- a) In relation to your participation in raffles or promotions and sending communications, Data will be processed until the interested party requests their erasure, or for a maximum period of two years.
- b) In relation to Website Browsing Data, they will be conserved until you revoke your consent and for a maximum period of one year. In any case, information on Web traffic is periodically deleted, so that EIT KIC Urban Mobility S.L.U keep only anonymized statistical usage data (without identification of Users).

6. TO WHICH RECIPIENTS WILL YOUR DATA BE COMMUNICATED?

Any Personal Data communication carried out by EIT KIC Urban Mobility S.L.U will always respect your Data protection rights and comply with the data protection regulation. Likewise, your Personal Data provided may be communicated to providers that helps EIT KIC Urban Mobility S.L.U to carry out the business, e.g. IT tools, technical support services, payment providers, social media, marketing software, raffles providers, some of which are located outside the European Economic Area and to third parties in order to manage your participation in contests or promotions.

EIT KIC Urban Mobility S.L.U guarantee that when your Data may leave the European Economic Area, the same protection level shall be maintained based on compliance with the provisions of European data protection regulation. In this regard, international transfers of Data shall be carried out (i) to countries with an adequate level of protection declared by the European Commission; (ii) based on the provision of adequate guarantees such as standard contractual clauses or binding corporate standards; or (iii) by virtue of the authorization of the competent authority or control body or under other conditions provided for in the regulation.

7. WHAT ARE YOUR RIGHTS?

You can request confirmation from EIT KIC Urban Mobility S.L.U regarding whether your Personal Data are being processed and, if so, you may access them. You may also request the rectification of inaccurate Data or, if applicable, request their erasure where, among other reasons, the Data are not necessary for the purposes for which they were collected.

In certain circumstances it is possible to request the limitation of the processing of your data, in which case EIT KIC Urban Mobility S.L.U will only retain them for processing claims and/or responding to complaints.

You may revoke your consent at any time. Once the revocation has been exercised, it will not be retroactive unless otherwise required by law, and your Data may be kept blocked for the prescription periods established by the applicable regulations.

You may also oppose the processing of your Data, in which case EIT KIC Urban Mobility S.L.U will not process your Data, except for compelling legitimate reasons or for processing possible complaints.
